THE ELECTION

Well, the election is over: I have been elected as your mayor. I succeed Harv Kitchens who has been mayor for eight years. There is no question that he deserves a break following his sixteen years of service as mayor and council member to this Town. Indeed, he and his wife Kay will be enjoying themselves out in cool Ruidoso, New Mexico from time to time this summer. Harv did a fantastic job and it is going to be difficult for me to replace him.

Tony Russo was re-elected to the council and has been appointed Mayor Pro-tem. Kim Dickey was elected to her first two-year term on the council. Kim will be replacing me as liaison on the Architectural Committee. Larry Fisher was elected to fill the remaining year of Becky Porter's term.

(Becky and her husband Robert moved out of Cross Roads for business reasons.) Larry writes most of the Cross Roads Times Newsletter articles on local businesses, and attends and has given talks at the Aubrey Chamber of Commerce meetings. One of his responsibilities will be to stay involved with our business program.

An additional item on the May 8th election was the re-authorization of a 1/4% sales tax designated for maintenance and repair of municipal streets. That item received more votes than did any of the candidates, even though all of the candidates were running unopposed. Most of the Town's citizens consider road maintenance and repair to be among the most important items in the Town budget.

PROVIDING LEADERSHIP

As mayor of Cross Roads, I plan to continue to promote the issues that have made our Town what it is today. The four most important are: one-acre minimum lot size, acceptable roads, no property tax, and no debt. Our single biggest source of income is sales tax

and with two major highways going through town the promotion of new and existing businesses must continue if we are going to meet our revenue needs. Even with the downturn in business and associated drop in income, we are continuing to maintain a profitable position. The key is to hold costs down until the business picture turns around.

Over the long haul, our one-acre minimum lot size, while providing a delightful place to live, supports our financial position, basically because high-density housing developments cost money. With respect to roads, road improvements made under the 2009-2010 budget were well done for the amount of money available. The chip and seal roads, approved by the town council, are going to take a few more months to settle in. Just slowing down to 20 mph will minimize the dust.

THE FUTURE

The budget for next year, starting on October 1, 2010, is now being developed. Housing starts this year are up by a factor of six over last year and we are seeing some new business activity on Hwy 380, which may indicate the start of a financial turnaround. Keep your fingers crossed.

Cross Roads borders Lake Lewisville on the south and is the beginning of horse country to the north. You just cannot find a better place to live than what we have here. We need to make the most of it. Remember, all Cross Roads Town meetings are open to all citizens and postings of time and location are on the door of the Town Hall. I hope to see you there.

THINK GREEN REBATE PROGRAM

CoServ Electric Think Green rebate program was established to help members make their homes more energy efficient. The program offers a wide range of eco-friendly options from complimentary lighting products to their HVAC tune-up rebate. *NOTE: If another audit is requested at the same residence within a 12-month period, there may be a \$100 fee added to your bill for the second energy audit. If you schedule an audit and you are not at your home when their auditor arrives for the appointment, a trip charge of \$50 may be added to your bill.

Blower Door Program

If you would like a more detailed energy audit, CoServ offers the option to add a blower door test. This service costs \$75 and is added to your next month's bill. This test will identify exactly where the leaks are in your home and even estimate how much money per year you are losing due to the air leakage. If interested, contact CoServ to book your blower door test today.

Think Green Rebate Program

CoServ now offers a range of rebates, including the following.

- ▶ CFL Program- Residential members who have an energy audit performed on their homes are eligible to receive up to \$50 worth of compact fluorescent lamps (CFLs) to be used in their most frequently used fixtures.
- ▶ HVAC Tune-ups - Residential members who have an energy audit performed on their home are eligible to receive up to a \$150 rebate on an HVAC tune-up performed by a qualified service professional.
- ▶ EnergyStar® Home Rebate - Members who build EnergyStar rated homes (that closed after June 1, 2009) are eligible to receive a \$550 rebate by submitting the EnergyStar certificate and builder verification that the home meets the EnergyStar standards.
- ▶ Heat Pumps - Members who replace existing

HVAC equipment (in electric-only, single-family homes) are eligible to receive a \$150 rebate for a 14 SEER High Efficiency Heat Pump and a \$300 rebate for a 15 SEER High Efficiency Heat Pump (or higher).

- ▶ Solar Energy Rebate - CoServ supports interconnected cogeneration with net metering – per the terms of our tariff. With our Think Green Rebate Program, they now offer a \$2.50 per watt rebate on solar generation (with a \$5,000 cap per member installation) until allocated funds are depleted.
- ▶ Commercial Lighting Rebate - Commercial / Industrial members who upgrade lighting fixtures can receive a rebate of .30 cents per watt saved (per fixture).
- ▶ Credits, Deductions and Programs - You may benefit from researching a variety of tax credits and deductions available for residential consumers, commercial buildings, home builders, small wind energy systems, solar panels, and by reading frequently asked questions on their website.

significantly benefit the business owners and residents of Cross Roads, Texas. The Insurance Services Office (ISO now recognizes the response of the Aubrey Fire Department into Cross Roads, Texas. This, in conjunction with the recent addition of Aubrey Fire Station 2 located at 220 Navo Road, will now allow Aubrey Fire Department to meet the criteria needed to extend the ISO Classification for Aubrey OPA, PPC - 6/9, in Cross Roads, Texas. These changes became effective on June 1, 2010. We encourage business owners and residents to check with your insurance companies to determine if or how this change will impact your insurance policy premiums.

Using the ISO Fire Suppression Rating Schedule (FSRS), ISO's Public Protection Classification (PPC) program helps insurance companies measure and evaluate the major elements of a community's fire suppression system. The PPC program is based on an evaluation of a municipality's fire department (50%), fire alarm (10%) and water supplies (40%). ISO analyzes this information and assigns an advisory number from 1 to 10. Class 1 generally represents exemplary fire protection and Class 10 indicates that the community's fire suppression program does not meet ISO's minimum criteria.

A community can also receive a split classification, e.g.

6/9. When properties are located over 5 road miles from a fire station, Class 10 (unprotected) applies. In the split class example, all properties located within 5 road miles of a fire station and within 1,000 ft of a fire hydrant receive the Class 6. Properties located beyond 1,000 ft of a fire hydrant receive the Class 9.

The PPC program recognizes the efforts of communities to provide fire-protection services for citizens and property owners. A community's investment in fire mitigation is a proven and reliable predictor of future fire losses. So, insurance companies use PPC information to help establish fair premiums for fire insurance — generally offering lower premiums in communities with better protection. By offering economic benefits for communities that invest in their firefighting services, the program provides a real incentive for improving and maintaining public fire protection.

The program also provides help for fire departments and other public officials as they plan for, budget, and justify improvements.

He is the son of Bruce and Dorian Arledge of Cross Roads, a member of BSA Troop 140 in Denton, and a senior at Ryan High School (Denton ISD). His Eagle Scout project was to lead scouts and volunteers in more than 80 hours of work to design and build special mounting blocks for the Aubrey Equestrian Center. The equestrian center works with mentally and physically handicapped children and adults through their interaction with horses.

Cross Roads Answers the Call

At about 6 PM on January 12, a massive earthquake struck the island nation of Haiti, devastating the capital city of Port-au-Prince in a matter of seconds. Like so many communities across this nation, the citizens of Cross Roads, Texas, were touched by the scenes of tragedy and loss, and wanted to help.

Oak Shores resident Gary Foss, Vice President of Planning and Marketing for AMR, parent of American Airlines, was uniquely positioned to help. By 10 AM the morning after the earthquake, three relief flights had been organized, each carrying more than 10,000 pounds of food, water and supplies to assist the residents of Port-au-Prince.

"American Eagle was the first airline to arrive in Port-au-Prince following the quake," said Foss. "In the days that followed, American and American Eagle were honored to provide relief supplies to the crippled city, and quickly partnered with the American Red Cross to funnel monetary donations from our customers and employees to speed necessary aid to the country."

Having accompanied relief trips to the devastated country, Gary noted to his wife, Cindy Foss, that so many of the quake's victims were children – left homeless and orphaned on the streets, many recovering in makeshift hospitals. Cindy, with her daughters- Ashlyn 13, and Mariah 7- decided to launch a campaign in Oak Shores to gather clothes, toys and other supplies for the children of Haiti. They passed out flyers and sent e-mails to their neighbors. Within a day, boxes began to pile up outside the Foss' Oak Point Dr. residence. Daughter Ashlyn penned a special message to the children by writing "Howdy from Cross Roads, TX!" on each box. Three days later, a 32-foot truck was filled to capacity and pulled out of Cross Roads, on the way to the airport.

"It was a labor of love," said Foss. "My daughter Ashlyn and I escorted three tons of toys and supplies donated through the generosity of the caring folks of this wonderful town. They were distributed directly to children and their mothers, gurney by gurney, in the largest field hospital for children in Haiti... to people who literally have nothing left in this world. I'll never forget the looks on their faces. It was heart-wrenching."

In the weeks following the quake, more than 30 additional AA relief missions were flown to Haiti's capitol city – all staffed by volunteer crewmembers and other employees who had given of their own time to offer assistance to those who had lost so much. But of all the relief missions flown by American, there was only one that had a plane entirely filled through the generosity and caring of a single town. A town that cared when it mattered, and provided comfort to the people of Haiti, as they struggle to rebuild their lives.
